a. Worship and Music Worship at Trinity in 2020



Where to begin? Worship is at the centre of Trinity's church life, and 2020 turned it all upside down. It started out with the regular mixture of creativity and engagement that we value together. In January we celebrated the baptism and confirmation of some adults who had been part of our Ridiculous Journey Study. We paired with the Sunday School to do some theme explorations: Speaking of Sin, and then 3 weeks about prayer, including an interactive all ages experience with prayer stations. In Lent we began exploring practices in our theme of "Rehearsing for Resurrection." On March 15 our final refrain was "We shall go out with hope of resurrection."

Then began the task of figuring out how to be church without actually going to church on Sunday mornings. Fortunately, we had been recording sermons and uploading to our YouTube channel for a couple of

years, so we knew how to do that already. We quickly determined that we would continue to post sermons for each Sunday. We would also send out print copies of these sermons to those who requested, particularly those who could not access internet and online options. Beth and I were both a little familiar with Zoom, having attended meetings by Zoom in the past, and decided to try bringing the congregation together that way in the short term, until we could come back to church. Initially, we assumed it might be a short term solution, and that we could have an Easter Confirmation celebration on whatever Sunday we returned to normal.

As we all know now, we never returned to normal. Instead, we experimented with various options available to us. In Holy Week, Julie and Beth did daily Facebook Live reflections, and we did a Zoom service of readings and reflections for Good Friday instead of our usual ecumenical effort. Easter presented us with our first opportunity to share communion online and in our own homes. Our pattern for the spring was to offer a more interactive Zoom experience live on Sunday morning with singing, listening to a Bible Story, talking about faith and life in a smaller group of 5 or 6 people, and prayer. We explored Easter hope in a lockdown, and a series on #parables4today. With group size capped at 25, we determined in June to do a confirmation service over Zoom with only the confirmands and their families in the church. Then came Beth's farewell. She posted a final sermon on YouTube and we held a virtual farewell service on Zoom with presentations and goodbye rituals.

Our usual pattern during the summer months is to share services with McKenzie United and First Presbyterian Churches. Neither of our partner churches was interested in exploring sharing options online, so we made the decision to cancel services for July. Julie provided a printed devotional resource for congregation members, as well as links to churches offering online services in various parts of the country. When Julie returned from vacation in August, she picked up the devotional theme of Psalms for the Summer, and continued it through August.

With September came the temporary re-opening, with various restrictions in code "yellow". We were able to open our sanctuary to those who wished to attend in person, while also maintaining our zoom church option for those sheltering in place. House group volunteers had brand new roles. Instead of making coffee,



they were taking contact tracing details. Rather than handing out bulletins, they were spritzing hand sanitizer. Greeting included making sure that people adhered to the physical distancing guidelines. Pam Lotun joined the regular Sunday team as Zoom host, and many hours were spent on Saturdays testing and re-testing the sound so that people could hear what was happening in the sanctuary, regardless of how they were in attendance. With people both in person and online, the format changed once again, and the sermon was recorded as part of the regular Zoom church experience, and small group breakout

conversations online were put on hold. Those at home were encouraged to sing along, while those in person listened, and were encouraged to dance, clap or play instruments. With one minister instead of two, we also added a monthly guest worship leader to our mix, and were pleased to welcome Wilma Shirriff and Norman Collier each twice during the second half of the year. The leadership team struggled trying to sort out a plan that would allow us to celebrate baptism. How would we determine who was allowed to be present to maintain public health orders? With no easy solution, all baptisms were simply put on hold.

With November came code Red, and the most restrictive lock down measures to date. Worship went back to online and in print only, although the format of streaming from the church was maintained. We began an Advent theme of "I'll be Home for Christmas" and a volunteer group called the Christmas Think Tank made plans for how to celebrate Christmas, whether or not we could be physically together. We were able to offer a variety of experiences including:

- Weekly virtual Advent services, inviting people to participate with Advent wreaths at home (whether or not they could join us online),
- a week of a "Christmas Carol-a-Day" on Facebook Live,
- an outdoor nativity display created by Bob and Donna Matthews,
- seasonal church interior décor that could be viewed online, festively decorated by Carol Zacharias, Donna Matthews and helpers,
- a Service of Remembrance and Hope jointly led online by ministers from First Presbyterian, St. Mary's Anglican, McKenzie and Trinity United Churches (with tech support and hosting by Trinity),
- a Christmas Solitude Evening of Music and Communion, featuring guest musicians Shane Smith, Audrey MacFarlane, Paige Bulachowski, Allison McEwing, Rhea & Ed Goertzen
- a Virtual Choir Anthem for Christmas Eve, utilizing the voices of 19 Trinity singers recorded individually, put together with images of congregation members lighting candles
- a Video Christmas Pageant created by the joint efforts of a number of Trinity families
- and Two identical Christmas Eve Services, offered over Zoom (incorporating the premieres of the pageant and anthem videos)

Thanks so much to the house group leaders, who have adapted and adapted again, as needs and opportunities have changed. Thanks to those who have assumed volunteer roles to help our worship, whether at church or online. Thanks to Barb for banners, and Carol for displays and organ playing. Thanks to Elaine for being available to play piano whenever and however was useful. Thanks audio-visual tech support and Think Tank volunteers. And thanks to everyone who has been so forgiving and graceful and flexible, willing to engage in brand new ways and try new things and overlook all of the glitches of trying to be church in a whole new way. Pandemic or no pandemic, we trust our Sunday mornings continue to connect us to God and to one another. Thanks be to God.

Senior Choir

I remember the songs we were practicing through Lent and for Easter in 2020. I was excited about them. They were a mix of traditional and contemporary, and they had been chosen to fit the weekly and special themes. We even had started learning a song called "All Will Be Well", as we heard about the Covid-19 virus that was impacting the world and starting to impact North America. And then, almost overnight, the country shut down. We learned about things like physical distancing, and the fact that group singing was a super-spreader sort of event. There was no safe way to sing together for the foreseeable future. And Thursday night choir practices were finished. And Sunday morning choir leadership for church was done.

There still is no safe way for people to sing in groups. While in most cases the standard required space between us is 6 feet, when you are singing, the standard is 20 feet apart indoors and at least 16 feet apart outdoors. Group singing 20 feet apart is really impossible! Finding ways to bring live music into our church life has been challenging. We have learned how to record hymn music, thanks to Elaine Verwey, Carol Zacharias and Barb Gillespie, who have helped me approximately once a month since March to figure out how to do that. To vary the voices we were hearing, I also connected with other churches across the country to share some of their recordings for our Sunday mornings. We put together a "Part of the Family" music video for Beth's farewell, with the help of the congregation (again, with Elaine on the piano). In the



fall when we were able to have some people in the church on Sunday mornings, Elaine and Carol offered instrumental music to give us some of that "live" music we were missing. Carol continued to provide pre-worship organ music when we went back into lock down and had to move back to online church only. And then we tried to find ways to take music from the church into people's homes. I did a week of carol singing on Facebook Live, inviting people to sing at home with me for a carol-a-day. With the help of the Christmas Think Tank and some guest musicians, we were pleased to have an evening of Christmas music from the church on December 21, and then for Christmas Eve, we prepared a special virtual arrangement of Silent Night. 19 different Trinity singers learned their parts by listening to a recording at home, and then were recorded one at a time before their voices were mixed together to make one choir music offering. Thanks to all of you who were willing to try a new

thing and be recorded all by yourself! Very special thanks to Elaine Verwey (who got left off the credits by accident!) who recorded the accompaniment and provided the foundation that everyone could sing to!



would have a baby in her advanced years. And yet here we are. It has certainly been a year for learning and growing. We have some time to go before we can sing together live, but I hope that we can continue to find creative ways to keep singing (separately) together, for as #142 in "More Voices" proclaims: 'Oh a song must rise for the spirit to descend. O a song must rise once again. Singing out God's praises and glory, the faithful voices blend, oh a song must rise for the spirit to descend!' (Paul Svenson)

How did you like the Christmas tree up in the choir loft at Christmas? It had to go there with the other items to depict the theme, "I'll Be Home for Christmas" so that it was in





It was truly a gift to have helped with the classes, to get to know this wonderful group of young people and to work so closely with Beth before her departure from Trinity.




Social Media

Trinity has been active on social media platforms for a few years now. With the pandemic lockdowns, social media became an increasingly popular way to share information and stay in touch with one another. In 2020, Trinity used social media for the following initiatives:

Facebook/Messenger – Trinity's Facebook presence is probably our most active social media platform. While we have a Page for information and inquiries are often received through the page and through

Messenger, most activity happens in the Trinity Facebook Group where content is posted, questions are asked, and discussions are held. Most church related announcements are shared online in this way (as well as through email and our website). In 2020, we used Facebook Live for the first time during Holy Week for daily reflections, and during Advent for a week of carol singing. Sunday worship links are posted in our group weekly, as well as links to our YouTube content. In the spring, we held two selfie-scavenger through the group, and received some very amusing photos. In May we invited people to post parables4today that they found around them in the world. In November, content was posted daily, and a Facebook Like and Share challenge was taken up by several members of the group. A daily prayer was also posted for each of the 12 days of Christmas. Our group had 198 members by the end of 2020.

Instagram – Our Instagram content has included a theme photo each week of 2020, as well as additional content as often as it can be created. In May, for example, we posted 15 or so #parables4today to enhance our parables project. As of the end of 2020, our Instagram account had 161 followers.

Twitter – Twitter is not well utilized by Trinity friends and followers, so it has not been our priority for social media engagement. While we post links to content weekly, we have not put in the effort to make our Twitter feed instant and newsworthy or to grow our followers. We currently have 25 followers who receive our content this way.

YouTube – Our YouTube channel is the place where we post all of Trinity's original video content, which is primarily sermons, although we also produce other video content occasionally as well. While people do not need to subscribe to access our content, we do have 48 subscribers who get notification each time a new video goes up. The most viewed content on our channel in 2020 was the "Best-worst-best Christmas Pageant", followed by the virtual choir anthem created for Christmas Eve.

Thanks to Gaby Chappellaz whose photographs have been a welcome addition to our social media presence in 2020.



Minister's Report - Julie Baker

"Hindsight is 20/20" – isn't that what they say?



I recall at the very first meeting of the leadership team in 2020 we talked about wanting to raise up some sort of "2020 vision" to hold on to for a year that we knew would bring some significant change for the church. Ha! We had no clue what was in store. My big personal adventure was going to be timing high level curling games, which were cancelled almost as soon as they began. Had we formulated a 2020 vision, it would have been irrelevant within only a few weeks. And now as we view 2020 with hindsight, we still have no idea what the implications and repercussions of this year will be for the church or the world.

As you will see in the pages of this report, nothing was 'as usual' in the year. Part way through Lent we suspended in person church, and held "holy week at home" and I got my first experience with "Facebook Live" videos. My work with the region as a "Fresh Start Facilitator" and as Worship Coordinator for our annual regional meeting were first adapted, and then moved to hiatus. Then there was "Easter at Home" and "Pentecost at home". We had to figure out how to say goodbye to a minister without getting together, so I learned how to cut together videos and we organized a drive-by parade. Despite a brief return to hybrid gatherings in the fall, we reached the end of the year and we were back "Home for Christmas".

Everything that we have known how to do as the church has been upended this year. The mission has remained but the methods have been drastically shifted. I have spent hours connecting with people over screens or on the telephone. We have used more postage for cards and other print mailings than we have for many years. I have probably spent just as much time on music and music preparation than I have in the past, but instead of a choir, have learned how to record separate tracks so that people can remain separate, and have spent a lot of time on my own singing into a microphone! Thanks to those who have taken time to join me in recording sessions at a physical distance, particularly Elaine, who keeps on playing! The number of funerals I led were dramatically reduced; many were delayed or postponed. Some funerals that might have been held in the spring waited until the fall, and when circumstances had not yet changed, alternative small outdoor gatherings took their place. In a couple of cases, we were able to livestream the funerals so that a wider group could participate. It has been difficult to support people through grief, when our tried and true methods for processing these changes are not possible.

In the midst of such strangeness, there were a few bright spots in 2020. As people were not able to come in to the church, a few extras were done to make the exterior of the church show life – the nursery school gave their entrance a complete facelift; the landscaping this summer was beautiful thanks to the labour of Mitchell Omichinski; and Bob and Donna Matthews created a nativity scene display for the church exterior. Others (with Carol) spent time creating interior visuals that could be seen on a screen. Several talented folk helped us knit pocket prayer shawls that we have been able to share with a number of people going through particular challenges. Some people even made pillowcases to give to youth for their unusual confirmation in June! It was great fun to work with people to put together a virtual pageant for Christmas Eve – special thanks to Gaby, Max and Amy Chappellaz for their energy for our special Christmas projects. We celebrated a zoom wedding with only 5 people in the church and all of the guests online, which was a delight for all involved.

2020 will not be quickly forgotten. We are forever changed. I am thankful for all that the year has allowed me to learn. I am so very thankful for the patience and good humour of all of those who have been part of Trinity church this year, as we have tried to do whatever we could, however we could. I am indebted to Pam

Lotun for her dedication and time as our Zoom host since September. We could not be managing our current live streaming Sunday morning system without her. I am thankful for the leadership team and other volunteers who have shifted with the circumstances again and again and helped us be the church as best we can. I also wish to express deep gratitude for Jacquie Bennet, who has assumed many additional responsibilities as we shift into a different sort of staff team. During 2020 I have appreciated her dedication, her creativity, her humour and her grace under pressure. As we move into 2021, we do not know where this pathway will take us. Martin Luther King, Jr. noted that "Faith is taking the first step even when you don't see the whole staircase." So let us continue to take our small steps as we can, trusting that God is with us – even, and especially, now.

Ministry Profile Team

This committee was established following the notice of Beth Kerr's resignation from Trinity. The original committee was made up of Jocelyn Baker, Greg Cochrane and Stephanie Verhoeven. There were inquiries with MacGregor's board members to see if there was any interest regarding possibly sharing a staff/clergy person.

Due to the pandemic Stephanie Verhoeven stepped away from the committee and it was at this time that the Ministry and Personnel Committee were asked if there were any members who would be interested in helping out on this committee. Yvette Brown, Sylvia Lyall and Jim Pehura volunteered to join the committee. The committee met via Zoom in May to discuss how we wanted to proceed. A second meeting was arranged in early June including Melanie Kauppila who is our pastoral relations liaison person from Prairie to Pine to help us identify some procedural considerations in our discussion. It was during this meeting that we got additional information we weren't aware of previously and decided based on how long it might take to secure personnel a recommendation was made to secure Pulpit supply for the fall term and the committee reconvened in the latter part of August.

Over the summer we worked on the Living Faith Story, Financial Viability Review and position descriptions for all staff. This included all current positions and a new position description for a Congregational Designated Minister (CDM) which is the position we felt best suited Trinity's needs at the present time. We used email to keep in touch (instead of Zoom) but slowed down our work over the fall until mid-December when we were contacted by MacGregor to see where we were at. We advised them that we were looking at a 75% CDM position, which left 25% available for them if they were interested in a joint venture. As of this writing, MacGregor has opted to advertise on their own and see what happens.

We approached our pastoral relations liaison in mid-December regarding next steps. We need approval from the region for our position description before we can advertise the position. As of this writing, we had submitted our CDM position description for consideration at their February meeting however received feedback before that meeting about revisions for consideration and we can resubmit for the March meeting. In the meantime we will put forward a revised CDM position description for congregational approval plus a backup plan at the Trinity annual meeting in February. In the meantime, pulpit supply has been arranged up to the end of May 2021.

g. Material Resources Trustees

One Trustees' meeting was held this past year on November 23 by Zoom.

We continue to receive any communication from the Portage Planning District regarding variance hearings and respond as necessary. The wisdom of investigating the possibility of getting a sprinkler system for the church brought to our attention. After some conversation it was determined that it would not be cost effective nor a priority at this time, given the current fire safety alarms in place. M. Omichinski inquired about property and landscaping issues. It was agreed that he would be given authority to make decisions about general and seasonal landscaping decisions. Any decisions that only impact a given season are completely under his authority. Any decisions with longer term impact or staff implications would need to have the approval of the trustees (or property chair, if one is appointed in the future).

Due to the pandemic, we decided to maintain current rental rates without increase for our primary users for 2021. Girl Guides suspended programming for the full year. To date, we continue to offer them space use without charge. We now have a full slate of people renting the parking spots on the north side of the building.

We continue to receive reports from our two major building partners. We heard from Big Brothers and Big Sisters (Dawn Froese) about their pandemic program adaptations. They were required to reduce staff during the spring, but in the fall, grants allowed them to bring back their 2 full time staff. The west door was fixed during the summer. Dawn reports that they are still feeling good about the partnership with Trinity and have no particular concerns. They appreciate the level of respect and team building that happens in this workplace.

Portage Ukrainian Nursery School (Lori Carpenter) reported that while they may not be thriving, the nursery school is doing okay. They have shifted their drop off and pick up arrangements so the south church entrance is currently remaining locked through the day. In the spring, staff went on E.I. and they got some local grants for PPE and for an electrostatic sprayer. In the summer their category of funding was taken away, and they are fighting the provincial decision. Over 10% of their families are now newcomers to Canada. The beautification grant from PCRC came through to re-do the south entrance and canopy for just under \$5 000. Due to the requirements of Covid, Cobbes are now coming quarterly to service the air exchanger, and PUNS have offered to cover that cost. They are very pleased with the partnership that we have between our two organizations.

We have received word that Steve Bergson has submitted his letter of resignation. We wish to thank Steve for his dedication to the responsibility of acting as a trustee for Trinity. We have appreciated his thoughtfulness, his experience and his wisdom, and we are grateful for the many ways he has served this community of faith.

Trinity Gardening Report for 2020



During the early spring, the growing beds were augmented with peat moss, and shallowly worked up. Lawn edging was added to the south side to give a defined bed border, and landscape renovations were undertaken in the area of the midsouth rain drain. The water hoses were relocated for a more convenient location of use, at the end of the side walk along the south wall. Poles were added to the front entrance banisters in order to mount potted flowers.

Bedding plants were installed (petunias, dusty miller, others) in the east beds and a few into in the south beds. Two varieties of cannas lilies were planted throughout the gardens. The many lovely perennials planted over the years, all came through in for a great showing. There was a little room for a few tomatoes and pepper plants along the south wall. A globe cedar was added in front of the west side kitchen vent (fully grown expected in 2028). Some pruning was done to the south side

ornamental crab tree, but more is needed). Two showy baskets of petunias (shout out to Solomon's) were mounted to poles on the east side.

Many thanks to the staff that kept everything well-watered throughout the summer. For 2021, the addition of a planter on the northeast side is planned, along with additional hard borders to limit egress of soil onto the east side walk. Also some major pruning of the crab tree above will have to be undertaken to address trunk damage and southerly sprawl. Areas for native grass plantings are also being considered.

If anyone is interested in having some cannas lily tubers for this year, or if you have any ideas of what you would like to see in Trinity gardens this season, please get in touch.

Despite 2020 being a year with many cancellations and deferred commitments, we were fortunate enough to stay on top of our annual maintenance and inspection schedules. This included the boiler, both East and South lifts and our emergency lighting. All were found to be without issue.

With the age of our building, several repairs were required throughout 2020. One of significance was an issue with the roof; boards on the south side fascia were coming down, and required the rental of a bucket truck. The birds that once called Trinity "home" have now had to take up residence elsewhere. Just before Christmas, the organ was broken and fixed remotely by a call in to Mantle & Buck (organ repair people), who talked us through getting it up and running.



The boiler saw repairs to the motor on one of the pumps, and as a preventative measure, the flame rods



were replaced and the ignitor cleaned. Our north side parking stalls were revamped, with signage, stall numbers and bumpers put in place to mark each spot. Rain caused trouble with a leaky eave and window in the parlour, which Ellwood McRorie took care of for us. They also fixed a window latch in the west wing. There is still a leaking issue at the south door, which we hope to have fixed in the new year.

The nursery school received a grant to give the south side a facelift, which included a new concrete pad and canopy. They have also added two stone planters to their front entrance. Seasonal décor included full, showy baskets on either side of the church in summer, thanks to Mitchell Omichinski, and thanks to Bob & Donna Matthews, a beautiful nativity display was put up on the south side of the church at the start of December, and remained until the start of January.

Stewardship

The stewardship strategy team (SST) consisting of Jim Moorhouse, Diane Stevenson, Larry Muirhead, Randy Owens, and Julie Baker have been meeting regularly utilizing zoom as required from the start of the Covid-19 social isolation rules set by health authorities. The team meets over the lunch hour to discuss strategy, issues, and processes surrounding Trinity's financial and stewardship health. The group would welcome anyone interested in joining our discussions. Essentially SST analyze and discusses the various sources of financial support opportunities that contribute to sustaining the expenses required to meet many of Trinity's operational needs.

We are very pleased to see that the members of Trinity have responded to various requests for increasing contributions required to help cover off cost of living and our reported operating losses realized every year. We are also very encouraged by the continuous involvement of our congregation to support Trinity with the generous donation of volunteer hours when possible.

Another major task of our group is to support a campaign theme which is one of the pillars to developing positive gains in stewardship. Most times our theme revolves around the concept that there are many different ways that people can give to support Trinity, that each weighted evenly in their importance. We see the value and scope that Trinity brings to various individual people and the community at large and therefore we are constantly discussing ways to introduce these benefits to members and potential new members.

We are hoping that we can base the direction of our action items going forward on the data we have been aggregating through our regular meetings and from opinions and comments shared by members. We are constantly exploring various options in attempts to offset a trend of an operational deficit. We are thankful that we have a minister, staff, and volunteers who have been effective at adapting to the Covid-19 reality, allowing Trinity to deliver meaningful and universally beneficial messages that that still have the same positive impact as they had pre Covid times. The effective and meaningful messages that Trinity delivers, along with the potential that Trinity possesses, easily motivates us to continually look for ways to keep moving forward.

Investment Committee Report



Trinity's investment grew to \$508,006.90 as of the end of 2020. This was up from \$461,758.22 at the end of 2019. The Investment Committee is quite pleased with the continued growth from the investment especially considering the economic environment in 2020.

Members of the Leadership Team along with the Investment Committee met in September of 2020 to discuss the idea of taking income from the investment to assist with operating shortfalls. It was agreed that we would take out \$25,000

(\$2,083.33/month) total for the year deposited into the Trinity operating account monthly starting January 2021. We have allowed the investment to grow for over two years and all believed that now is a good time to begin using some of the growth to assist with operating expenses.

In 2020 Stride Credit Union changed their investment provider from Credential Asset Management to Journey Wealth. We feel it is important to notify the congregation of this change but want you all to know this has no impact on our investment. Paul Davidson is still our Financial Advisor, the investment we purchased has not changed. It is a name change and a change in the brokerage house where are investments are held only.

Thanks to the work everyone has done in 2020 to keep Trinity an important part of people's lives and like every year thank you for the faith you have put in us to make decisions on behalf of the congregation.

Resident Profile of Giving 2020 (Operating)




