Sundays:

Category 3 Remit: Establishing an Autonomous National Indigenous Organization - Lynne did a presentation to move us through the remit information. Some discussion held on ways to share this information with the congregation. Perhaps sharing a video would be meaningful. To be continued at the next meeting.

Letter received from Judy Hare – Sacraments Elder Training: We strongly encourage those Communities of Faith /Pastoral Charges without a Called or Appointed Ministry Personnel already in place for the period beyond July 1, 2023, to identity and support someone to take the training for sacraments elder. Those seeking training must be a member of the Community of Faith/Pastoral Charge. Given the limited number of Ministry Personnel on the pulpit supply list, the relatively large number of communities of faith/pastoral charges without paid accountable ministry personnel and the frequency with which many communities of faith/pastoral charge celebrate communion, it is wise to be able to be self-sufficient in the provision of sacraments. Having one or more people take the training does not mean that they are required to follow through with a request for licensing if they discover it is not something they feel called to do. Having trained sacraments elders does not mean that your community of faith /pastoral charge cannot have sacraments provided on occasion by Ministry Personnel on the pulpit supply list.
