John Stafford (including Thanksgiving Sunday), Rev. Chuck Ross and our very own Brenda Brand (Easter Sunday). We wish to thank the house groups and their leaders for all of the ways they coordinate participation in worship, whether at church or online, including: door hosts, ushers, scripture

readers, candle lighters, coffee hosts, sound operators, communion servers, as well as other roles that may come up time to time. #### Trinity Search Team 2023

Search Committee - What a busy year!

We started 2023 with a search team training session on January 7, 2023, and ended the year by welcoming Elijah and family to Canada!!

Our joint team consisted of Donna Matthews, Alan Brown and Diane Stevenson from Trinity and Mary Hodge, Audrey Gray, Wendy Murray and Sharla Davey from MacGregor. Our liaison minister was Elizabeth Brown.

Meetings, meetings and more meetings, emails, emails and more emails - this was the reality of our committee throughout the year!

Prior to 2023, a position summary, financial viability review and community of faith profile were put together. A lot of work, but this enabled the search committee to hit the ground running. The search committee signed up for ChurchHub, created a profile for ChurchHub and uploaded these documents plus a few more. There is always a learning curve with a new program - we experienced a learning curve with ChurchHub <sup>©</sup>.



Once our profile was approved, we were able to review candidates' profiles and start making lists of potential ministers to interview. We learned a lot from MacGregor's previous experience using ChurchHub. We narrowed our search, requested videos of sermons, and set up interviews, then second interviews with Julie present. #### e. Material Resources *Trustees*

The Trustees of Trinity met four times throughout 2023. Changes last year to our Board of Trustees included Patti Brown named as a Trustee at the Congregational Meeting, Sunday March 12, 2023. With the resignation of Kim Guy, Mitchell Omichinski was elected as chair. We also accepted Bev Bachalo's resignation last year. Many thanks to both Bev & Kim for their years of dedication in serving as Trustees.

Building security: The Trustees are looking into surveillance cameras and more lighting to protect our staff, and the building. With all of the possible technologies available, they will find out what they might recommend.

*Insurance:* The United Church of Canada has its own insurance coverage that is based on cross country United Churches involvement to be able to get a better rate.

Sanctuary Steps: The surface on the cement steps and their extreme slipperiness in ice and rain conditions is problematic. The Trustees have spoken with Elwood McRorie Ltd. and the summer of 2024 they will see that follow up is done to redo the steps with better traction material. Black stair nose strips were placed on the edge of the steps to help with visibility.



*Boiler:* Discussion regarding the efficiency and condition of the current boiler system. It is hoped that there is a way to add air conditioning to the current system. This would need to be two units, one being for the sanctuary and one for the office area of the lower level. Dave and Larry will work on this together, looking at feasibility and getting estimates for what the cost would be to do this. Quotes received for replacement of boiler, with two boilers. Point West gave us an estimate of \$65,000.00 with electrical coming in at an estimate of \$4,285.00. The Trustees will investigate grant moneys available to help with the cost. Faithful Footprints is a grant program with the United Church of Canada for churches that are looking at reducing their carbon footprint and how could that be used to pursue funding for the boilers. Through Faithful Footsteps there is money available based on the type of energy efficient boilers being purchased. This would cover a partial part of the expense and other grants will need to be in touch with Prairie to Pine Regional Council Property Commission. The proposed purchase and how the cost will be covered would need to be submitted to them. This is required by the region when capital expenditures exceed a given amount.

*Tenants:* The Trustees met with Big Brothers Big Sisters and Portage Ukrainian nursery school. With Government grant money the Nursery School carpeted the stairs (help with softening sound) and an area up to the gym, some new equipment for the gym purchased, tumbling mats. Solar lighting has been added in the parking lot. Money has been set aside for a speed bump. Another window has been added to upstairs.

The children can see family and activities going on. After reviewing the Portage Ukrainian Nursery School the rent will be increased by 3% for 2024.

Next year will be the 50<sup>th</sup> anniversary of Big Brothers, Big Sisters. They would like to do a winter wonderland fund raiser at the church with each area in a different theme (November time frame). This would be for a weekend with interactive things for families and would still be set up for Sunday coffee time in the gym. The first Sunday in Advent is December 1 and possibly this could be incorporated with worship planning as well. BBBS asked if there could be a moratorium for any rent increases in 2024. We were in agreement to withhold any increase for the new year.

#### Trinity Gardening Report 2023

The gardening year, like last year, began in early spring with a campaign to raise funds in support of Ukraine for their tragic situation. By selling surplus canna lilies, collected in part from Trinity's gardens in 2022, we were able to pass a \$3,500 cheque to the Ukraine Refugee Local Settlement group helping fund the resettlement of refugees in the Portage area. Unfortunately due to an over winter storage failure, about 1/3 of the crop collected in fall of 2021 was lost. This limited the planting potential in 2023 and our ability to repeat this fund raising project in 2024. A big thanks to businesses that supported the project this past year (The Portage Mall; Rona; Canadian Tire; Hutterian Book Store).

The first signs of flower bed life following the winter, were tulips planted many years ago along the south church wall. These tulip beds were expanded in the fall of 2022 with plantings in the front south east corner of the church and in the garden area along the kitchen east wall. These survived the winter for the most part and provided some new tulip delights in April. After tulips had run their course, it was time to plant the usual rows of canna lilies along the east and south walls. A total of four varieties were planted this year, with contributions from parishioners, taking up much of the space available for annuals. The canna lilies provided a backdrop of light green and purple tinged foliage along with flower spikes of ruby orange in late summer.

The usual assortment of geraniums, petunias,



marigolds, begonias were planted in the front beds and planters. With many thanks, most of the petunias were donated by the UCC. A border of dusty miller (added with gazanias this year) completed the annuals in the front beds. Many of the annuals were dug up in the fall before killing frost and grown all winter at the mall centre court. Along with added contributions from the community (flowering hibiscus, banana tree, rubber plant, among other plants) they make a tropical / semi tropical display of vegetation at the mall.

Pole mounted Petunia baskets adorned the front steps again this year, with colors pink, red, violet, and white. This coming year these colors along with a splash of yellow has been ordered from Solomon's. Strong winds whipping around the north east corner of the church, continue to be the greatest threat to this flower display. The month of May frequently being a windy month, the baskets were not put out until mid-June. Still, there were too many days last year to my dislike, of wind pruned petunia salad fouling the flower beds below.

The perennial display of hostas, rose bushes, holly hocks, lilies, Russian sage, barberry, and clematis along with shrubs of Sistine cherry, variegated dogwood, among others, rounded out the garden display for 2022. However one new feature was added this year, and that was two areas on the south lawn dedicated to mixes of wild flowers. The hosta at the north east corner was divided and the division was established along the north wall of the auditorium. Plans are to continue hosta additions along this wall in 2024, and contributions to this effort are welcome and requested. Also new this year were four varieties of mid to late season flowering canna lilies planted along the south wall.

With regards to changes in hardscape, a pole was attached to south east corner of the church to help support our climbing vine, and to limit its tendency to fall into the flower beds mid-summer. Another pole is planned to help further anchor the vine on it's the other side for the same issue. The 150 ft. garden watering hose had to be replaced after theft, and security measures were built to protect its replacement. Again as last year, there was some theft of flowers from the planter and beds, which were difficult to replace in mid-summer. Hopefully an exterior camera security system planned for church will help with this continuing problem. Can theft of ones flowers be taken as a back handed compliment?

It has been a challenge finding volunteers to sit on the property team. If you are interested in being part of the two-month rotation, the only requirements needed are a basic knowledge of odd jobs and a willingness to fix things. For larger jobs, tradespeople are called in. Many thanks to Mitchell for his time and energy in filling in the gaps in the absence of a property committee.



Some of the activities, projects and upgrades included

installing an exterior north door (off of BMO parking lot, complete with wiring it into our security system. Point West Electric was in to install a receptacle in the front office entrance, which has proven very useful for plugging in the doorbell, as well as the vacuum cleaner. Traffic signage was placed at the east end of the south parking lot & nursery school canopy to encourage motorists to slow down.

Repairs during the year included both the office window and the south door crash door had the glass replaced from a break-in prior to Christmas. Summer saw vandalism & theft to our property – a garden hose was broken and replacement hoses were purchased, and plants were stolen. A continual stream of needles & garbage on the north resulted in exterior lighting was upgraded on the north side over the BMO parking lot door, as well as the north Tupper Street door.

Ongoing general maintenance included plumbing & septic issues in both washrooms, lighting throughout the church and boiler and lift maintenance. Annual maintenance and inspection/servicing schedules on the boiler, both east and south lifts and emergency lighting were followed and found to be without issue.

Thank you to everyone who shows appreciation for our beautiful church.

hard work in 2023 to keep Trinity United Church an important party of people's lives and thank you for the faith you have put in our team to make decisions on behalf of the congregation.

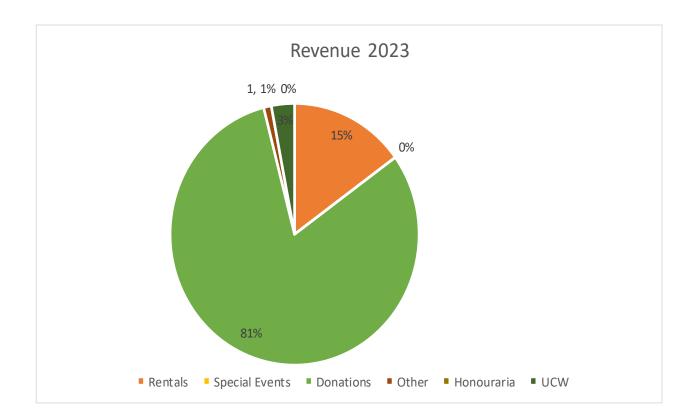

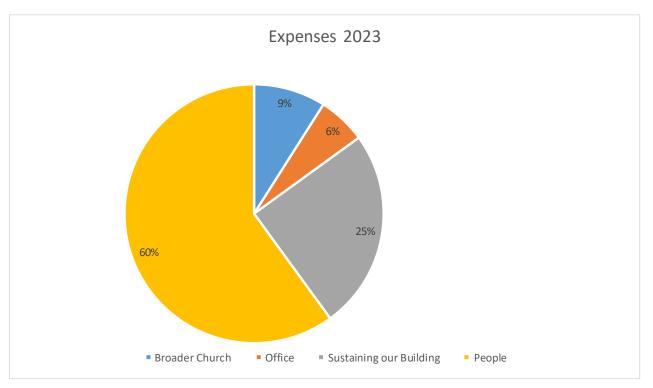
