UCW Report – Christmas Baking Sale planned for December 08 following worship

Property: Annual Fire Extinguisher inspection & maintenance performed. Electrical outlets for parking have been turned on for the cold winter months. As of Nov 22 - Jacquie still waiting for a response from the supplier of the sanctuary project bulbs re: error message on south side.

Stewardship: The campaign has started and we are running themes on Gratitude throughout this month both in the weekly email and announcements. A mailing was done but the Canada Post strike challenged the mailing plan. Many of the stewardship packages ended up being delivered by the TriniTidings deliverers. Thanks!

Trustees: Trustees are yet to meet with the Tenants once a date has been set. On that meeting, Trustees will discuss the new lease (rental) rates with the Tenants. This is annual check with our lease renters is meant to set up the rent for 2025 before the end of 2024.

### Safe Workplace Task Group:

It was reported that someone had entered the church at the end of service yesterday that had been injured. Stephanie attended to him and helped him make contact with a family member. Police and ambulance were contacted and he was left in their care. He was very appreciative of the kindness done for him.

Stephanie noted there wasn't really anyone else comfortable dealing with the situation other than herself and wondered if there was some sort of training that could be offered so that others

could feel like they could offer help. Suggested to have water bottles and granola bars and a first aid kit on hand. There is money available in the benevolent fund to have a small stash of these things. Comment shared that it was good the door was open for him to seek shelter, it would be wise in the future for ushers or someone to just be aware when someone does come in. This is an area where there may be some overlap with the work of the Safe Workplace Task Group.

Trini Tidings: The newsletter went out November 22. With the mail strike, many extra were hand-delivered.

Prairie to Pine Region:

Town Hall is to take place this Wednesday November 27 at 7:00 pm (via Zoom). All are invited by the Prairie to Pine Regional Council. Focus: How can congregations create community and connection and sustain these spaces of worship? There are positive aspects and challenging elements. (examples: How can we get our youth to gather on a regular basis? What are the next steps when people are tired and hesitant to commit to planning or attending events?)

Affirming Ministry: You will see in that newsletter a suggestion about shifting our vocabulary for “White Gift”. When we were putting together the newsletter, we often wonder how people who are unfamiliar with church culture will understand our lingo and jargon. It occurred to us that perhaps it is time for us to start calling our outreach ministry at Christmas something else. For this year, the formerly known as “White Gift” is being called “Gifts of Grace”.
